ARTICLES OF INCORPORATION

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation is Avenger Termite and Pest Control of Florida

ARTICLE II PRINCIPAL OFFICE
