## ARTICLES OF INCORPORATION

*The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.*

### ARTICLE I NAME

The name of the corporation is Avenger Termite and Pest Control of Florida, Inc.

### ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be

### ARTICLE III SHARES

The number of shares of stock that this corporation is authorized to have outstanding at any one time is:

1000 shares

### ARTICLE IV PREEMPTIVE RIGHTS

The shareholders of this corporation shall have preemptive right to subscribe to those issues of shares or securities of this corporation as permitted by Florida law.

### ARTICLE V PRIOR OFFER TO OTHER STOCKHOLDERS

In case a stockholder desires to sell his or her shares of stock, he or she must first offer them for sale to the remaining stockholders, it being the intention to give them a preference in the purchase of the shares, and any attempted sale in violation of this provision is null and void.

A stockholder desiring to sell his or her stock shall file notice in writing of his or her intention with the secretary of the corporation, stating the terms of sale, and unless those terms are accepted by any or all of the other stockholders within thirty days, they shall be deemed to have waived their privilege of purchasing and the stockholder will be at liberty to sell to anyone else.

### ARTICLE VI STOCKS

Incorporator Ravinder Juneja will own 55% of the stock and incorporator Ilana Svirsky will own 45% of the stock until such time that each incorporator will have equal contribution to the corporation and at that time each incorporator will 50% of the stock.

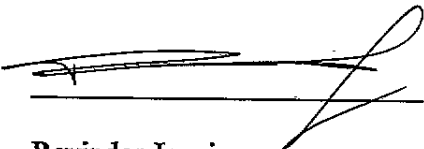

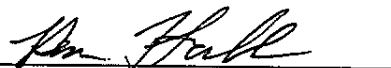
