The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

#### ARTICLE I NAME

The name of the Corporation is Oriental Art & Furniture, Inc..

#### ARTICLE II DURATION

The duration of the Corporation is perpetual.

## ARTICLE III PORPOSES OF BUSINESS
