THE UNDERSIGNED Subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a Corporation under the laws of the State of Florida.

**ARTICLE I - NAME**

The name of the Corporation is ROW COACH MEDIA, INC. The official street and mailing address for the Corporation is 7635 Abbott Avenue, Apt. 8, Miami Beach, Florida 33141.

**ARTICLE II - PURPOSE OF CORPORATION**

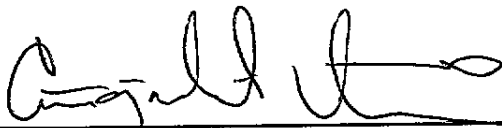
**ARTICLE VIII - INCORPORATOR**
