Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

**FIRST:** The date of filing of the Articles of Incorporation was February 4, 1999.

**SECOND:** All of the directors of the Corporation approved a resolution amending Article I of the Articles of Incorporation by written consent dated the 21st day of August, 2008, in accordance with the provisions of Section 607.0821 of the Florida Statutes, and all of the shareholders of the Corporation approved the resolution amending Article I of the Articles of Incorporation by written consent dated the 21st day of August, 2008, in accordance with the provisions of Section 607.0704 of the Florida Statutes. **ARTICLE I - Name**

The name of the Corporation is **S. V. Alavi Enterprises, Inc."**

**THIRD:** The effective date of these Articles of Amendment shall be the date of filing with the Florida Department of State.

**FOURTH:** The remainder of the Articles of Incorporation shall remain unchanged and in full force and effect.
