I, the undersigned subscriber to these Articles  $\frac{1}{2}$  Incorporation, being a natural person competent to contract,  $\frac{1}{1}$  a corporation for profit under the laws of the State of Florida.

## ARTICLE I

The name of the corporation is DISTINGUISHED LEATHER, INC.

#### ARTICLE II

The corporation is authorized to and may engage in any activity or business which is lawful in the State of Florida.

#### ARTICLE III
