The Corporation may engage in any activity or business permitted under the laws of the United States of America and the State of Florida.

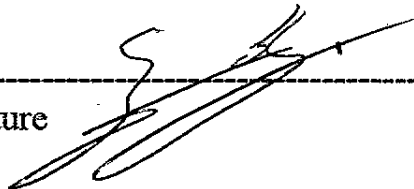

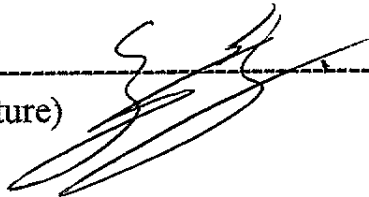
