ARTICLE I

NAME: The name of this Corporation is STAR MARKETING OF MT. DORA, INC., and its address is 9063 St. Andrews Way, Mount Dora, Florida 32757.

ARTICLE II

DURATION: This Corporation shall exist perpetually.

PURPOSE: The purpose is to engage in any activities or business permitted in the laws of the United States and Florida.
