#### ARTICLE I - NAME

The name of the corporation is Global Maintenance, Inc., 6005 Babcock Street SE, Palm Bay, Florida 32909 (Principal Office of Registered Agent).

#### **ARTICLE II - DURATION**

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.
