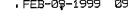

ARTICLES OF INCORPORATION

OF

SECRETARY OF STATE TALLAHASSEE, FLORIDA

The undersigned, acting as (a) incorporator(s) of a Professional Association under the Florida General Corporation Act, adopt(s) the following Articles of Incorporation:

FIRST: The name of the Professional Association shall be CHIROPRACTIC PAIN MANAGEMENT P.A.
