ARTICLES OF INCORPORATION

OF

CHIROPRACTIC PAIN MANAGEMENT P.A.

SECRETARY OF STATE

The undersigned, acting as (a) incorporator(s) of a Professional Association under the Florida General Corporation Act, adopt(s) the following Articles of Incorporation:

FIRST: The name of the Professional Association shall be **CHIROPRACTIC PAIN MANAGEMENT P.A.**

SECOND: The period of duration of the Professional Association is perpetual.

THIRD: The purpose or purposes for which the Professional Association is organized to practice chiropractic pain management, as permitted under the laws of the United States and of this state, and to do everything necessary, proper, advisable, or convenient for the accomplishment of said purposes, and to do all other things incidental to them or connected with them that are not forbidden by the Florida Professional Association laws or by other law, or by these articles of incorporation, and to carry out the said purposes in any state, territory, district, or possession of the United States, or in any foreign country, to the extent that these purposes are not forbidden by the law of the state, territory, district, or possession of the United States, or by the foreign country.

FOURTH: Authorized Shares.

Number. The aggregate number of shares of stock that the Professional Association shall have the authority to issue is 1000 shares of Capital Stock with a par value of \$1.00 per share.

Initial Issue. 100 shares of the Capital Stock of the Professional Association shall be issued for cash at a par value of \$1.00 per share.

Stated Capital: The sum of the par value of all shares of Capital Stock of the Professional Association that have been issued shall be the stated capital of the Professional Association at any particular time.

Dividends: The holders of the outstanding capital stock shall be entitled to receive, when and as declared by the Board of Directors, dividends payable either in cash, in property, or in shares of the capital Stock of the Professional Association.

No classes of Stock: The shares of the Professional Association are not to be divided into classes.

No share in Series: The Professional Association is not authorized to issue shares in series.

NINTH: An affirmative vote of a majority of the shares of the Professional Association shall be required for any shareholder action.

TENTH: The shareholders shall have the power to adopt, amend, alter, change or repeal the Articles of Incorporation when proposed and approved at a stockholders meeting, with not less than a majority vote of the common stock.

ELEVENTH: The holders of the common stock of this Professional Association shall have preemptive rights to purchase, at prices,

terms and conditions that shall be fixed by the Board of Directors, such of the shares of the stock of this Professional Association as may be issued for money (or any property or services from time to time, in addition to that stock authorized and issued by the Professional Association. The preemptive right of any holder is determined by the ratio of the authorized and issued shares of common stock held by the holder of all shares of common stock currently authorized and issued.

TWELFTH: The address of the principal office 3820 Coco Plum Circle, Coconut Creek, FL 33063.

THIRTEENTH: The shareholders of this Professional Association shall be allowed to vote their shares cumulatively so as to give one shareholder as many votes as the number of directors to be elected multiplied by the number of said shareholder's shares, to distribute them among as many candidates as said shareholder may wish. Notice must be given by any shareholder to the President or a Vice President of said Professional Association not less than 24 hours prior to the time set for the holding of a shareholders' meeting for the election of directors that said shareholder intends to cumulate his vote at said election.
