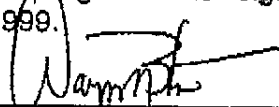
ARTICLE VIII. INCORPORATOR

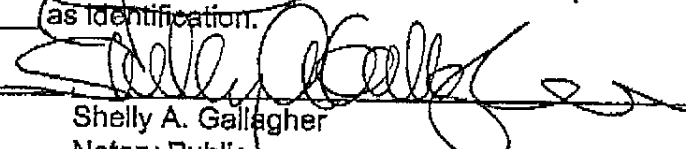
