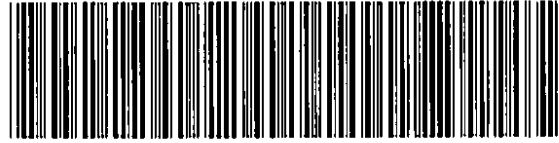

Pursuant to Sections 607.1003 and 607.1007 of the Florida Business Corporation Act, Associated Monitoring Services, Inc., a Florida corporation (the "Corporation"), hereby certifies that:

**FIRST:** The Corporation was originally incorporated in the State of Florida by filing Articles of Incorporation on February 8, 1999, effective February 4, 1999. These Amended and Restated Articles of Incorporation shall amend, restate and supersede in their entirety any and all prior Articles of Incorporation, as amended, including, without limitation, any articles of amendment, filed with the Florida Secretary of State from the date of the Corporation's original incorporation through the date hereof.

**SECOND:** These Amended and Restated Articles of Incorporation were adopted and approved by the Corporation's Board of Directors, with approval of the sole shareholder of the Corporation, on December 31, 2020.

**ARTICLE I – Name**

The name of the Corporation is Associated Monitoring Services, Inc.

**ARTICLE II – Principal Office**

The street address and mailing address of the principal office of the Corporation is 2251 Rosselle Street, Jacksonville, Florida 32204-3125.

**ARTICLE III – Term of Existence**

The duration of the Corporation is perpetual.

**ARTICLE IV – Purpose**

The purpose of the Corporation is to engage in any lawful act or activity for which a corporation may be organized under the Florida Business Corporation Act.

**ARTICLE V – Shares**

The total number of shares of capital stock which the Corporation has authority to issue is 1,000 shares of common stock, no par value per share.

**ARTICLE VI – Registered Office and Agent**
