ARTICLE I

NAME: The name of this corporation is: ADVANCED BEHAVIORAL NETWORK, P.A.

ARTICLE II

COMMENCEMENT OF EXISTENCE: This corporation shall commence to exist on the date of the subscription of these Articles, if filed within five (5) days with the Secretary of State.

ARTICLE III

PURPOSE: This corporation is organized for the purpose of transacting any and all lawful business permitted under the laws of the United States and the State of Florida and to provide professional services such as psychological services.

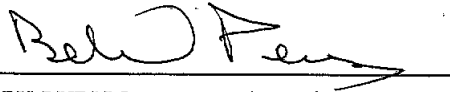

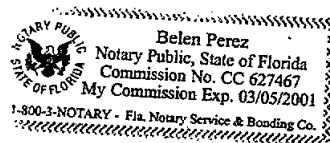

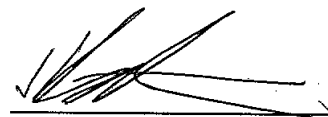
