**ARTICLES OF INCORPORATION**  
**OF**  
**LISA GAYLORD PRODUCTIONS, INC.,**  
**A FLORIDA CORPORATION**

The undersigned, acting as Incorporator of LISA GAYLORD PRODUCTIONS, INC., a Florida corporation (the "Corporation") under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

**ARTICLE I**

**NAME AND ADDRESS**

The name of the Corporation is LISA GAYLORD PRODUCTIONS, INC., a Florida corporation, and the street address of the initial principal office of the Corporation is 915-8th Street, Apt. 203, Miami Beach, Florida 33139, and the mailing address of the Corporation is 915- 8<sup>th</sup> Street, Miami Beach, Florida 33139.

**ARTICLE II**

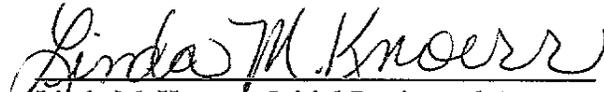
