## ARTICLES OF INCORPORATION OF

#### Earl Edward Naecker, Inc.

The undersigned incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following articles of incorporation:

#### ARTICLE ONE NAME & ADDRESS

The name of the professional association is Earl Edward Naecker, Inc. Its principal office and place of business is located at 114 Laurie Drive, Ormond Beach, Florida 32176.

#### ARTICLE TWO CORPORATE DURATION

The duration of the corporation is perpetual.

## ARTICLE THREE PURPOSES

The general purposes for which the corporation is organized are:
