
I am writing to ask you for a waiver of penalties and interest for reinstatement of this corporation. Our excuse has been a comedy of errors beginning with:

- 1) The mailing address for this corporation is incorrect so we never received the original application. As the registered agent, we were receiving official papers for this client. However, we live in a very small village and mail was ~~never delivered directly to our office. Instead our mail was delivered to a~~ bank in the same building in which we lease our space and we found that there were times when things did not reach us. In order to rectify the situation we rented a P.O. Box and had all of our mail forwarded to that box.
