ARTICLES OF INCORPORATION

OF

J&M MOLINA, INC.

KNOW ALL MEN BY THESE PRESENTS: That the undersigned person, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME OF CORPORATION

EFFECTIVE DATE

The name of the corporation shall be J & M MOLINA, INC.

ARTICLE II - DURATION OF EXISTENCE

This corporation shall exist perpetually, commencing on February 1, 1999, the date these Articles were executed...
