ARTICLES OF INCORPORATION  
OF  
LAMBORN ANIMAL SERVICES, P.A.

I, the undersigned, hereby incorporate myself for the purpose of becoming a professional corporation under the laws of the State of Florida, and under the provisions of Chapter 608, Florida Statutes, as amended by the "Professional Services Corporation Act" of the State of Florida, Chapter 621, Florida Statutes, providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE I

NAME OF CORPORATION: The name of the corporation shall be:

LAMBORN ANIMAL SERVICES, P.A.

ARTICLE II

NATURE OF BUSINESS: The general nature of the business and the proposed objects and purposes to be transacted, promoted and carried on are to do any and all things hereinafter mentioned as fully and to the same effect and extent as a natural person might or could do, viz:

- A. To engage in every aspect of the general practice of veterinary medicine as a licensed doctor of veterinary medicine as more particularly defined in the Veterinary Medical Practice Act, Florida Statutes 474 as now in existence or hereafter amended.
- B. To render the professional service involved only through its officers, agents and employees who are duly licensed or otherwise legally authorized within the State of Florida and in good standing to render the same professional service of this corporation.

- C. To invest its funds in real estate, mortgages, stocks, bonds and any other type of investments.
- D. To own real and personal property necessary for the rendering of the public service hereby authorized.
- E. This corporation shall not engage in any business other than the practice of veterinary medicine.

### ARTICLE III

CAPITAL STOCK: The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is Five Hundred (500) shares of common stock, having nominal or par value of One (\$1.00) Dollar per share. The consideration to be paid for each share shall be payable in lawful money of the United States of America, or in property, labor or service which, in the judgment of the Board of Directors, shall be of the valuation equivalent to the value of the stock to be issued.

### ARTICLE IV

PRINCIPAL OFFICE AND RESIDENT AGENT: The initial post office address of the principal office of this corporation in the State of Florida, 1315 South Glencoe Road, New Smyrna Beach, Florida 32168, and that the Resident Agent is the same. The Board of Directors may, from time to time, move the principal office to any other business in the State of Florida.

### ARTICLE V

DIRECTORS: This corporation shall have one (1) director, initially. The number of directors may be increased from time to time and By-laws adopted by the stockholder, but shall never be less than one (1).

ARTICLE VI

EXISTANCE: The corporation shall have perpetual existence.

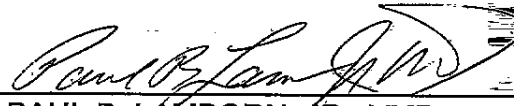

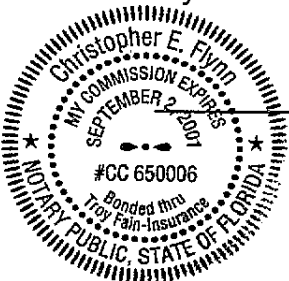
