Pursuant to the provisions of the Florida Statutes, on March 16, 1999, the incorporator of Venturi International Inc., a Florida corporation (the "Corporation"), adopted the following resolutions by written consent:

RESOLVED: That the name of the Corporation should be changed to Ramson Mining Corporation.

RESOLVED: That the Articles of Incorporation as filed with the Florida State Department should be amended to reflect the foregoing resolutions.

NOW THEREFORE, in accordance with the foregoing resolutions,

The first sentence of Article I of the Corporation's Articles of Incorporation is deleted and the following inserted in its place:
