2. TERM OF EXISTENCE: This corporation shall exist perpetually unless dissolved according to law.



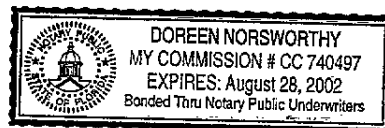


