The undersigned incorporator, for the purpose of forming a corporation for profit, under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

**FIRST.** The name of the corporation is **Champon International Corporation.**

**SECOND.** The principal place of business and mailing address of this corporation shall be: 22400 Sea Bass Dr., Boca Raton, FL 33428.

**THIRD.** The aggregate number of shares of Capital Stock, which the Corporation has authority to issue, is ten thousand, all of which shall be one class of common stock having a par value of \$ 1.00.

**NINTH.** The Corporation shall indemnify incorporators, officers and directors to the full extent permitted by law.


c. The directors of this Corporation shall have the sole discretion to determine the expenses for which the before mentioned incorporator shall be reimbursed.
