The undersigned subscriber to these Articles of Incorporation, Richard W. Applegate, being a natural person competent to contract, hereby acknowledges and files these ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the laws of the State of Florida.

<u>ARTICLE I</u>

CORPORATE NAME

The name of this Corporation is R.W.A. Trucking, Inc.. The principal office and mailing addresse of the corporation is 2250 17th St. S.W., Naples, FL 34117.

ARTICLE II

DURATION

The Corporation shall have perpetual existence, commencing upon the filing of these Articles.

ARTICLE III

PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful business.

CAPITAL STOCK

The Corporation is authorized to issue 7500 shares of \$1.00 par value stock, which shall be designated "common shares."
