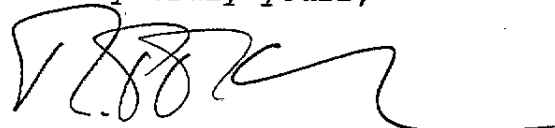

**ARTICLE I - MODEL 12, INC.**

The name of this corporation is MODEL 12, INC.

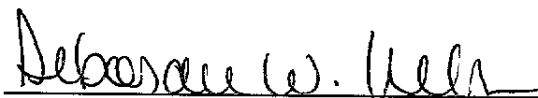

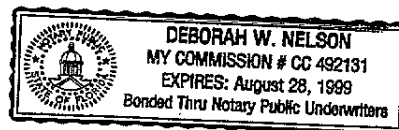
