The name of the corporation shall be ACCENT TILE & STONE, INC.

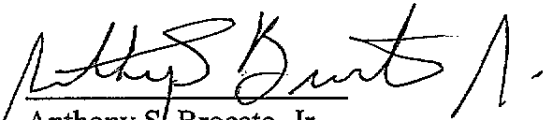

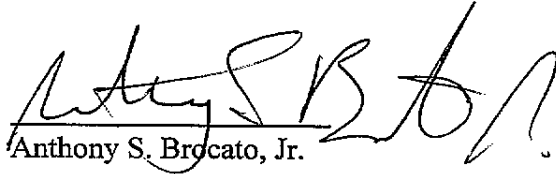
