ARTICLES OF INCORPORATION

OF

KINDER ACADEMY, INC.



ARTICLE I. CORPORATE NAME

The name of this corporation is: KINDER ACADEMY, INC.

ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE III. PRINCIPAL ADDRESS

The corporation's principal address is:

ARTICLE IV. CAPITAL STRUCTURE

- A. The Board of Directors can create any type of Capital Structure necessary for the operation of the Corporation. There can be different stocks of Par Value and Non-Par Value.
 - B. The initial capital structure of KINDER ACADEMY, INC., is \$5,000.00.

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 1000 shares of common stock having no par value.

ARTICLE V. TERM OF EXISTENCE

This Corporation shall have perpetual existence, commencing upon filing of these articles.

This Corporation shall have one director initially. The number of directors may be increased or diminished from time to time by Bylaws adopted by the stockholders, but shall never be less than one.

ARTICLE VIII. INITIAL DIRECTOR
