ARTICLES OF INCORPORATION

OF

MUNOS ENTERPRISES, INC.

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE T. - NAME

The name of the corporation is MUNCE EXTERPRISES, INC.
