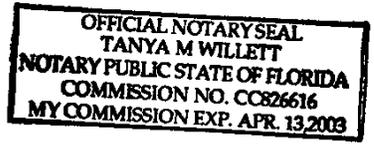
1. Jarred Schumer is the President of JAZZ & COMPANY, INC., a Florida corporation, (hereinafter "Corporation").
