## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION BLACKSTONE PORTAL, INC.

SECRETARY OF THE PARTY OF THE P Pursuant to the provisions of Florida law, the undersigne Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- The name of the Corporation is BLACKSTONE FORTAL, INC.
- 2. The following Amendment of the Articles of Incorporation was adopted by the Shareholders of the Corporation on the u day \_, 2007, in the manner prescribed by Florida law.

Article VI of the corporate charter filed on February 9, 1999, is amended as follows:

### "ARTICLE VI Capital Stock

The Corporation is authorized to issue ONE HUNDRED (100) Shares of ONE AND NO/100 DOLLARS (\$1.00) par value common stock which shall be designated "Class A Voting Common Shares"; and ONE HUNDRED (100) shares of ONE AND NO/100 DOLLARS (\$1.00) par value common stock which shall be designated "Class B Nonvoting Common Shares". The Class A and Class B shares shall be entitled in all respects to equal rights and privileges except that each share of Class A shall be entitled to one (1) vote and each share of Class B shall be nonvoting stock."

- 3. The number of shares of the Corporation outstanding at the adoption was six hundred (600), and the number of shares entitled to vote thereon was six hundred (600).
- 4. The number of shares voted in favor of such Amendment was six hundred (600), and the number of shares voted against such Amendment was none.
- 5. This Amendment shall become effective immediately upon filing with the Department of State of Florida.
