The name of this organization shall be:

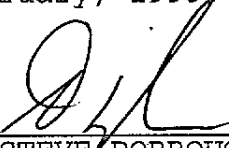
SUPREME INK INTERNATIONAL, INC.

5. There are no other Stockholders or Directors entitled to vote on this amendment.

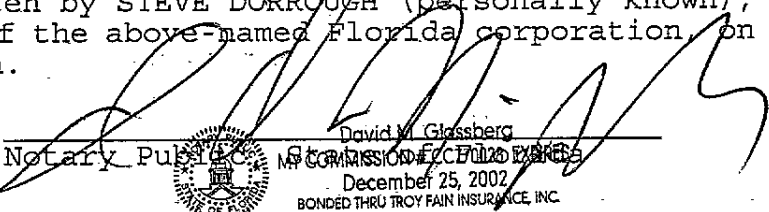
