ARTICLES OF INCORPORATION OF MTM PARTNERS, INC.

SECRETARY OF STATE

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is MTM Partners, Inc.

ARTICLE II - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business permitted under the laws of Florida.

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue one thousand(1,000) shares of One Cent (\$.01) par value common stock, which shall be designated as "Common Shares." All of said stock shall be payable in cash, property (real of personal) or labor or services in lieu thereof at a just valuation to be fixed by the Board of Directors.

ARTICLE IV - VOTING RIGHTS

ARTICLE V - TERM

ARTICLE VI - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as my be done without issuance of fractional shares) at the prices at which it is offered to others.

The private property of the stockholders shall not be subject to the payment of the corporate debts to any extent whatever. The corporation shall have a first lien of the shares of its stockholders and upon the dividends due them for any indebtedness of such stockholders to the corporation.
