ARTICLES OF INCORPORATION
OF

SUNCOAST TRANSPORTATION OF BRADENTON, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is SUNCOAST TRANSPORTATION OF BRADENTON, INC.

ARTICLE II

The existence of the corporation shall begin on the filing of these articles.

ARTICLE III

The street address of the principal office of the Corporation is 7413 2nd Avenue Northwest, Bradenton, Florida 34209.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 2000 of One Dollar Par Value, all of which shall be Common Shares.
