

The undersigned subscribes to these Articles of Incorporation, each a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

#### ARTICLE I

NAME: The name of the corporation is:

N. T. & T. IMAGES INC.

#### ARTICLE II

#### NATURE OF BUSINESS:

- (a) The general nature of business to be conducted by the corporation shall be to engage in the repair and maintenance of x-ray machines, and the delivery of newspapers.
- (b) To purchase, improve, develop, lease, exchange, sell, dispose of and otherwise deal in and turn to account, real estate; to purchase, lease, build, construct, erect, occupy and manage buildings belonging to or to be acquired by is corporation, or any other person, firm, or company.
