ARTICLES OF INCORPORATION

OF

DeFee Associates, Inc.

PASECRETOR SIZE

The undersigned subscriber to these Articles of Incorporation being a natural person, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I.

The name of the corporation is: DeFee Associates, Inc.

ARTICLE II.

The general nature of the business to be transacted by this corporation is to engage in the business of the development, implementation, management and marketing of computer software and other technology.
