

# **ARTICLES OF INCORPORATION**

## **OF**

**FC&DC INC.**

THE UNDERSIGNED, natural person of legal age, acting as incorporator of a corporation under the laws of the State of Florida, adopt the following articles of incorporation for such corporation:

### **ARTICLE ONE**

The name of the corporation is **FC&DC INC.**

### **ARTICLE TWO**

The period of duration is perpetual.

### **ARTICLE THREE**

The purpose for which the corporation is organized is to engage in remodeling and new construction of commercial and/or residential buildings and all other business activity for which corporations may be incorporated under Chapter 607 of the Florida Statutes.

### **ARTICLE FOUR**

The aggregate number of shares which the corporation shall have authority to issue is **100** shares of common stock having no par value or amount of par value each.

### **ARTICLE FIVE**

The corporation will not commence business until at least **FIVE HUNDRED DOLLARS** (\$500.00) have been received by it as consideration for the issuance of shares.

### **ARTICLE SIX**

Provisions for the regulation of the internal affairs of the corporation are governed by the bylaws which shall be adopted by a majority of directors.

## ARTICLE SEVEN

The address of the initial registered office of the corporation is 240 N. Frederick Ave. Suite C, Daytona Beach , Florida, 32114 and the name of its initial registered agent at such address is **DAVID M. WEAVER.**, who by his signature states that he is familiar with and accepts the duties and responsibilities as registered agent for this corporation.

## ARTICLE EIGHT

The address of the principal place of business is 240 N. Frederick Ave., Daytona Beach , FL, 32114.

## ARTICLE NINE


