THE UNDERSIGNED, acting as the sole incorporator of Tiny Enterprises, Inc. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

Article I

Name

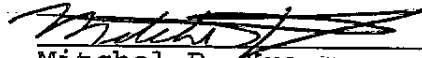
