OFFICERS AND DIRECTORS

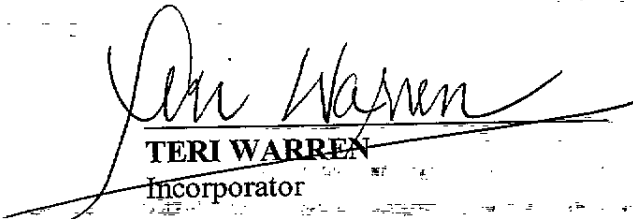

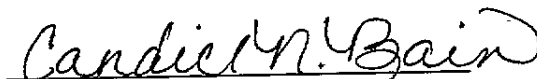
