ARTICLE I



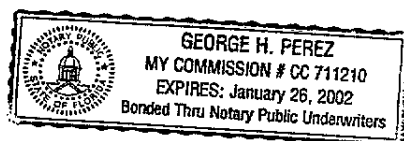
