Articles of Incorporation

EP Services Unlimited, Inc.

ARTICLE 1

NAME AND DURATION

Sec. 1 - The name of the corporation shall be EP Services Unlimited, Inc.

Sec. 2 - The period of its duration is perpetual and will commerce at the time of the Articles of Incorporation by the Department of State.

ARTICLE II
