

**ARTICLE I**

**NAME**

The name of this corporation is **Embler Creative Consultants, Inc.**

**ARTICLE II**

**PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business permitted under the laws of Florida.

**CAPITAL STOCK**

### BY-LAWS



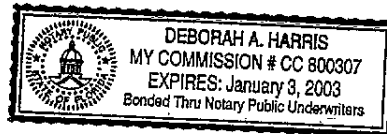
