# ARTICLE ONE - NAME AND PRINCIPAL OFFICE LOCATION

The name of this corporation shall be: MAYHEM INC. The principal office address is 5970 S.W. 18th Street, Suite 194, Boca Raton, Florida 33433.

# ARTICLE TWO - DURATION

This corporation shall commence existence upon the filing of these Articles of Incorporation by the Department of State, State of Florida, and shall have perpetual existence.


