

ARTICLES OF INCORPORATION OF BO*DIRT I, INC.

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is Bo*Dirt, Inc. and the principal address and principal place of business is 2240 Belleair Road, Suite 160, Clearwater, Florida 337674.

ARTICLE II - REGISTERED OFFICE AND AGENT

The address of its registered office in the State of Florida is c/o PATEL, MOORE & O'CONNOR, P.A., 2240 Belleair Road, Suite 160, in the City of Clearwater, County of Pinellas, Florida 33764. The name of its registered agent at such address is Steven W. Moore, Esquire.
