ARTICLE I NAME

SECRETARY OF STATE TALLAHASSEE, FLORIDA

THE NAME OF THIS CORPORATION SHALL BE CORAL WIRE INC.

ARTICLE II COMMENCEMENT & DURATION

THE COMMENCEMENT OF THIS CORPORATION'S EXISTENCE SHALL BE AT THE TIME OF THE FILING OF THESE ARTICLES OF INCORPORATION BY THE FLORIDA DEPARTMENT OF STATE. THIS CORPORATION'S DURATION SHALL BE PERPETUAL.

ARTICLE III PURPOSE
