SKS VENDING CO.


- FIRST: The name of this corporation is **SKS VENDING CO.**

- SEVENTH: The name and address of the incorporator is **Henry Siwek**, 7105 SW 110 Terrace, Miami, Florida 33156.

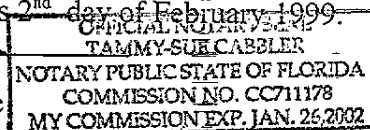
