ARTICLES OF INCORPORATION ABSOLUTE FAVORITES, AMELIA ISLAND, INC. SECRETARY OF STATE

The undersigned incorporator hereby makes, subscribes to, acknowledges, and files these Articles of Incorporation for the purpose of organizing and incorporating a Corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the Corporation is Absolute Favorites, Amelia Island, Inc., and it shall be hereinafter referred to as the "Corporation". The street address of the initial principal office of the Corporation, and the mailing address of the Corporation is Park Place, Suite 6, 5472 First Coast Highway, Amelia Island, Florida, 32034.

ARTICLE II

The time and date on which corporate existence of this Corporation shall begin is upon the filing of these Articles of Incorporation, and this Corporation shall have continuous and perpetual existence thereafter.
