



ARTICLE OF INCORPORATION

OF

AJIA HOUSE, INC.



I, the undersigned, hereby make, subscribe, acknowledge, and file these Articles for the purpose of becoming a corporation under the laws of the State of Florida.

ARTICLE I

The name of this Corporation shall be AJIA HOUSE, INC.

ARTICLE II

The general nature of the business to be transacted shall be:

- A. To transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act or engage in any trade or business which can, in the opinion of the board of directors of the Corporation, be advantageously carried on in connection with or auxiliary to the corporate business.
- B. To acquire such property, real and personal, as may be necessary to the conduct of such business and to conduct the business in the manner in which it is ordinarily conducted by others similarly engaged.
- C. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE III

The principal place of business and mailing address of this Corporation shall be 2428 Monaco Drive, Tallahassee, Florida 32308.

ARTICLE IV

The capital stock of this Corporation shall consist of FIVE THOUSAND (5,000) shares of \$1.00 par value.

The whole or any part of the capital stock of this Corporation shall be payable in lawful money of the United States of America, or property, labor or services at a just valuation to be fixed by the Directors. Property or labor may also be purchased with the capital stock at such valuation as shall be fixed by the Directors.

ARTICLE V

Shares of capital stock of this Corporation shall be issued initially to the following persons and in the amount set forth opposite their names:

Alan R. Weekley 2428 Monaco Drive 5,000 Shares Tallahassee, FL 32308

The price and terms at which, and the time within which, such shares may be offered and sold shall be consistent within the provisions authorized by the Florida Business Corporation Act.

ARTICLE VI

The following additional provisions for the regulation of the business and for the conduct of the affaires of the Corporation, and creating, dividing, limiting and regulating the powers of the Corporation, its stockholders and Directors are hereby adopted as part of these Articles of Incorporation:

- A. No person shall be required to own, hold, or control stock in the Corporation as a condition precedent to holding an office in this Corporation.
- B. The Directors may prescribe a method or methods for replacement of lost certificates, and prescribe reasonable conditions by way of security upon the issue of new certificates therefor.

ARTICLE VII

To the full extent permitted by law, the Corporation shall indemnify each person made or threatened to be made a party to any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative or investigative (including one in the right of the Corporation to procure a judgment in its favor) by reason of the fact that he, or his testator or interstate, is or was a director, officer, employee or agent of the Corporation or served any other corporation, partnership, joint venture, trust or other enterprise in any capacity, at the request of the Corporation.

ARTICLE VIII

The street address of the initial registered office of this Conforation is 2428 Monaco Drive, Tallahassee, Florida 32308, and the name of the initial registered agent at that address is Alan R. Weekley.
