The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

NAME:

The name of this corporation is:

ARTICLE II

NATURE OF BUSINESS:

- (a) The general nature of business of the corporation to be conducted by the corporation shall be to engage in maintenance service for commercial and residential properties.
