## ARTICLES OF INCORPORATION

OF

## NAILS BY ODILIA INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

#### ARTICLE I

## NAME

Inc.

The name of the corporation is Nails by Odilia and its address is 801 SW 8<sup>th</sup> Street, Miami, Florida 33130.

### ARTICLE II

### **DURATION**

The duration of the corporation is perpetual.

### ARTICLE III

## **PURPOSE**

The general purpose for which the corporation is organized are:
