OF

ARTICLE I

(NAME)

The name of this corporation is SCOTT W. SITTERSON, P.A.

ARTICLE II

(DURATION)

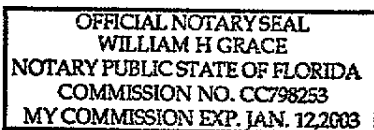
