Pursuant to the provisions of Section 607.1003 of the Florida Business Corporations Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

Article 1 - Name of Corporation

The name of the corporation shall be known as **ROCKING A-LAND AND CATTLE CO.**, rather than ROCKING A- QUARTER HORSES, INC. Specifically, Article 1 of the originally filed Articles of Incorporation filed on February 15, 1999, shall be amended to that extent only. The mailing address for the corporation shall remain as originally filed, which is 6830 S.W. Belvoir Drive, Arcadia, FL 34266. Also, any other reference to the name of the corporation in said originally filed Articles of Incorporation and Certificate of Designation of Registered Agent is hereby amended. The date of adoption of the amendment was the 26<sup>th</sup> day of June, 2000, and the number of votes cast for the amendment was sufficient for approval.

Article 2 - Balance of Articles

The balance of the Articles of Incorporation shall remain as originally filed.
